### CONTRACT STATEMENT

Purchaser's obligations to this contract are likewise limited to the same conditions. A minimum deposit of \$100.00 is required to secure the performance date and time. Should the purchaser cancel the engagement for any reason other than by mutual consent, then the deposit is not refundable. All services including musicians or entertainers, furnished thereunder, shall be under the exclusive direction and control of the Producer, who retains the right to designate, discipline, select or substitute who shall perform. Producer accepts this engagement as an independent contractor who, along with designated cooperative musicians and/or entertainers assume self-responsibility for and federal, state, or local taxes and any public liability. This agreement shall be considered as made and interpreted under the laws of the State of Texas. This constitutes the sole, complete, and binding agreement between the parties hereto, whereas this Mariachi cooperative acts only as an agent for the Producer and assumes no liability thereunder. The total sum is due and payable upon completion of said performance immediately after the performance in CASH ONLY - unless previous arrangements have been made and stated on this contract.

Contract shall be void if not returned within 14 days of the initial date of contact. Please return one copy with your security deposit.
